<p>The IFRA Standards regarding use restriction are based on safety assessments by the panel of experts of the RESEARCH INSTITUTE FOR FRAGRANCE MATERIALS (RIFM) and are enforced by the IFRA Scientific Committee.</p> <p>Evaluation of individual fragrance ingredients is made according to the safety standards contained in the relevant section of the IFRA Code of Practice.</p> <p>It is the ultimate responsibility of the customer to ensure the safety of the final product (containing this raw material) by further testing if needed.</p> <p>For essential oils, percentages of restricted substances are determined according to gas chromatography data (level detection is 100 ppm).</p> <p>For compositions, percentages of restricted substances are determined by calculations from raw materials of the blend.</p> <p>For other raw materials (isolates, absolutes,...), percentages of restricted substances are determined from suppliers information.</p>

Hand wash laundry detergent (including concentrates); Laundry pre-treatment of all types (e.g. paste, sprays, sticks); Hand dishwashing detergent (including concentrates); Hard surface cleaners of all types (bathroom and kitchen cleansers, furniture polish, etc.); Machine laundry detergents with skin contact (e.g., liquids, powders) including concentrates; Toilet seat wipes; Fabric softeners of all types excluding fabric softener sheets; Household cleaning products, other types including fabric cleaners, soft surface cleaners, carpet cleaners, furniture polishes sprays and wipes, leather cleaning wipes, stain removers, fabric enhancing sprays, treatment products for textiles (e.g., starch sprays, fabric treated with fragrances after wash, deodorizers for textiles or fabrics); Floor wax; Fragranced oil for lamp ring, reed diffusers, potpourri, liquid refills for air fresheners (non-cartridge systems), etc.; Ironing water (Odorized distilled water); Dry cleaning kits (involving manual application on the textile)	Class 10A

Candles of all types (including encased); Laundry detergents for machine wash with minimal skin contact (e.g. Liquid tabs, pods); Automated air fresheners and fragrancing of all types (concentrated aerosol with metered doses (range 0.05-0.5mL/spray), plug-ins, closed systems, solid substrate, membrane delivery, electrical, powders, fragrancing sachets, incense, liquid refills (cartridge), air freshening crystals, solid non aerosol car diffuser); Air delivery systems; Cat litter; Cell phone cases; Deodorizers/maskers not intended for skin contact (e.g., fabric drying machine deodorizers, carpet powders); Dry cleaning kits (placed in the dryer); Dryer sheets and fabric softener sheets; Fuels; Insecticides (e.g., mosquito coil, paper, electrical, for clothing) excluding aerosols/sprays; Joss sticks or incense sticks; Dishwash detergent and deodorizers – for machine wash; Olfactive board games; Paints; Plastic articles (excluding toys); Scratch and sniff; Scent pack; Scent delivery system (using dry air technology); Shoe polishes; Rim blocks (toilet); Toilet gel; Scent beads	Class 12
