It is the ultimate responsibility of the customer to ensure the safety of the final product (containing this raw material) by further testing if needed.</p> <p>For essential oils, percentages of restricted substances are determined according to gas chromatography data (level detection is 100 ppm).</p> <p>For compositions, percentages of restricted substances are determined by calculations from raw materials of the blend.</p> <p>For other raw materials (isolates, absolutes,...), percentages of restricted substances are determined from suppliers information.</p>
